DUE DATE ON FEES

All fees are payable **IN ADVANCE**. Full time monthly fees must be paid before the 5th of the month or weekly fee paid on Monday. Part time fees are due **monthly** on the **first day** scheduled.

THERE WILL BE A LATE CHARGE OF \$2.00 PER DAY FOR EACH DAY PAST DUE.

NSF CHECKS

There will be a \$30.00 charge on all NSF checks and after two such checks, cash or certified check will be required for payment.

OVERTIME CHARGES

You are subject to overtime charges if your child(ren) are here before or after their scheduled hours. The applicable Drop-In Child Care hourly rate will be used for any overtime hours.

AFTER-HOURS CHARGES

Our hours are 5:30AM – 6:30PM. There will be a charge of \$1.00 per minute per child for each minute your child(ren) are in our care after 6:30PM.

SCHEDULE CHANGES

All schedule changes must be in writing two weeks in advance of desired change. This includes vacations and withdrawals. If these changes are not made in advance you are responsible for the scheduled fees. Exceptions to this must be approved in writing by the Director.

VACATION

Vacation is without charge in weekly increments up to two weeks per year. To avoid charges you must notify the Daycare in writing at least two weeks in advance.

Special arrangements should be made with the Director for a leave of absence for such things as child birth and summer break. There is a \$50.00 deposit required to reserve your child's spot.

ILLNESS

There is no credit given for time lost for illness. If illness is more than one week, talk to the Director to see if we can work with you in some way.

MISCELLANEOUS

There is a \$27.50 charge if we do not receive notification at least one hour in advance when your child will not be present for a scheduled pickup from school or if your child is repeatedly late for his/her scheduled pickup.

DAILY RECORD OF ATTENDANCE

Parents must sign their children in to and/or out of the daycare center. For billing purposes, if a parent fails to sign their child in, we will use 6:00 AM. If a parent fails to sign their child out, we will use 6:30 PM.

Holidays Facility is Closed: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.
